MLAANZ Annual Conference – “SEA CHANGE – NAVIGATING THE FUTURE” – 12-14 September 2019, Auckland

We welcome you to attend this year's Annual MLAANZ Conference. The conference is being held from the 12-14 September in Auckland, New Zealand. The conference program will soon be released.

The theme of this year's Conference is “Sea Change – Navigating the Future”.

We will explore how the global digital evolution is rapidly penetrating and shaping the maritime sector, and how new technologies are propelling the maritime sector into the future.

We will discuss market trends, and the potential opportunities that digitization (in all its forms) may create for companies willing to embrace these technologies.

We will also consider some of the many challenges that the maritime sector may face regarding implementation of the digital evolution, from a logistics, business and a cultural perspective.

The breadth and complexities of the maritime sector is well recognized, with its broad spectrum of participants from different disciplines integrating into a single supply chain. How will each aspect of the supply chain be affected by digitalization and how can optimization be best achieved?

The impact of the digital evolution on the current legislative or regulatory regime is also fertile ground for debate (eg, can an unmanned autonomous vessel ever be “seaworthy” in the traditional sense of the term, or is the traditional meaning of “seaworthiness” in need of adaptation or reform?)

How will digitization impact of allied sectors such as the insurance market for example?

The conference will focus on the future of the shipping sector with the advent of digital transformation and new technologies.

Some specific topics to be considered will include: monitoring the fisheries sector, maritime cyber security, IMO's current priorities, future proofing the maritime sector, innovation and sustainability, the move toward clean ships and MARPOL, ship arrests and admiralty law topical issues.

The social events should prove to be entertaining and good networking opportunities.
