The reprieve from Covid in the early part of 2021 permitted a return to in person events and on the strength of this the NSW branch set about planning its events for 2021.

**Seminar Programme**

Much effort was made to organise a Marine Insurance seminar which was due to be held on 14 July 2021 at Greenway Chambers. Due to the Sydney Covid lockdown, the decision was made not to proceed with the seminar. Instead, the seminar was successfully delivered as a spring seminar via webinar on 1 September 2021 and virtually hosted by Greenway Chambers. Over 120 people from - overseas, New Zealand and across to WA registered to attend the seminar. We were very grateful to Justice Stewart of the Federal Court of Australia for his engaging introduction to the seminar and to the following speakers for their presentations and willingness to adapt to fluctuating arrangements :

While many states continued to experience a lockdown due to Covid and with the cancellation of the Brisbane national conference, the Branch hosted a webinar on 25 November 2021. This provided an opportunity to hear about the maritime industry from experienced industry participants. We were grateful for career insights provided by:
