  the status of the review of section 11 of the Carriage of Goods by Sea Act which will have
  significant implications for the maritime industry in Australia and beyond. Peter also discussed
  cases involving time bars on misdelivery claims, and recent laytime and demurrage disputes
- Dr Robin Bowely, senior lecturer UTS Faculty of Law the maritime sanctions regime in the United Kingdom and Australia in relation to Russia post-Ukraine occupation. Dr Bowley discussed the sanctions regime here in Australia and in the United Kingdom relating to Russia, post-Ukraine occupation
